Great Lakes ATTC partnered with Treatment Alternatives for Safe Communities (TASC, Inc.) to publish *Medication-Assisted Treatment for Opioid Addiction in a Criminal Justice Context – Implementation Brief for Community Supervision* (2016). Great Lakes ATTC is currently discussing a technical assistance project with Indiana on substance use disorder treatment models in jail settings.

Mid-America ATTC developed regional and state summit models on the use of medications for addiction treatment.

Mountain Plains ATTC, through the work of the National Frontier and Rural ATTC, sponsored a webinar on technology in criminal justice and drug court settings (recorded webinar available). They also worked with South Dakota's criminal justice programs to provide contingency management services.

New England ATTC offers a suite of criminal justice products that could be applied to drug courts:

- Criminal Justice Treatment Planning MATRS: Utilizing Criminogenic Risk Assessment to Develop Effective Treatment Plans
- Behavioral Management in the Criminal Justice Population: Applying Motivational Incentives to the Offender Population online course
- Buprenorphine Treatment Training for the Criminal Justice Workforce – 6-hour course
- Adopting and Retaining Motivational Interviewing in the Criminal Justice Workforce – a 3-phase workforce development series:

Phase 1: MI: Engaging to Facilitate Change. A credited, self-directed on-line course.

Phase 2: Advanced MI Skills. A credited 1-day face-to-face training.

Phase 3: MI Assessment: Supervisory Tools for Enhancing Proficiency (MIA: STEP). A 2-day credited training for clinical supervisors.

Northeast & Caribbean ATTC evaluated a pilot substance abuse treatment model with Brooklyn Treatment Court and Samaritan Village. They also managed the Cultural Proficiency in Drug Court training project, offering instruction on culturally-informed drug court practice with African Americans and Hispanics and Latinos.

Northwest ATTC is in discussion with the Idaho Drug Courts about providing training for drug court judges on MAT and Motivational Interviewing.

Pacific Southwest co-sponsors an annual Problem Solving Court Conference in Arizona and a Drug Court Conference in California.

South Southwest ATTC provided grant application assistance and evaluation services for the Rapides Drug Court in Alexandria, LA, for SAMHSA Drug Court Expansion/Enhancement Grants.

National American Indian and Alaska Native ATTC presented a webinar on opiate addiction in Indian Country for the National American Indian Court Judges Association, which works with the Healing to Wellness Courts, a cultural adaptation of drug courts. Center staff:
