SBIRT CURRICULUM INFORMATION

1. **Screening for Substance Abuse:** How brief and effective screening for substance abuse can improve patient outcomes.

Module Objectives: Select appropriate screening tools for hazardous substance use problems based on patient history and characteristics Screen patients effectively for substance use problems. Interpret hazardous substance use screening results Triage patients to the appropriate level of care.

2. Brief Interventions for Substance Abuse: Brief interventions when another treatment is the focus.

Module Objectives: Employ motivational interviewing techniques to develop rapport with the patient Implement a brief intervention that is tailored to the patient and the severity of the substance use problem Modify the brief intervention for substance abuse as appropriate to the patient or situation Provide the patient with education and resources needed

3. **Referral to Treatment and Follow-up Care:** Options for specialty treatment, planning and arranging substance abuse treatment referral.

Module Objectives: Follow-up with patients who have received brief interventions for substance use problems Determine the need to refer a patient for substance abuse treatment Select the proper type of treatment center, specialist, and/or counselor for patients with substance use problems Prepare the patient for a referral for substance abuse through education and motivation and followup up after the referral Collaborate and communicate effectively with the specialist to ensure ongoing patient care after referral
