CRA is comprehensive behavioral program that has been empirically supported with inpatients, outpatients, and homeless populations. In addition, three recent meta-analytic reviews cited it as one of the most cost-effective alcohol treatment programs currently available. CRA is based on the belief that environmental contingencies can play a powerful role in encouraging or discouraging addictive behaviors, and draws on the strength of communities and families to guide a person towards a more rewarding lifestyle.
