Often, this can lead to unclear job descriptions, miscommunication, and siloing of services intended to strengthen an organization's service delivery model. The Northeast & Caribbean and National Hispanic and Latino ATTCs have partnered to bring you an exciting and interactive 4-part training for those who are currently supervising peers and/or are interested in integrating peer-based recovery services into their organization. You will leave this training better equipped to provide effective and tailored supervision to peers on your team, fostering a fully integrated model of care, and creating a competitive advantage for your organization.
